



Code of Ethics

LOVE, PEACE, TRUTH, RIGHT CONDUCT, NON-VIOLENCE

For SQ Members, Practitioners and Teachers

The following Code of Ethics ("Code of Ethics") has been prepared to assist SQ members, certified SQ practitioners and teachers, as well as More Truth Will Set You Free workshop facilitators, maintain the highest integrity and standards of the SQ family. Material violation of the Code of Ethics may result in cancellation of SQ membership and/or healing system or More Truth Will Set You Free certifications or authorization. Such cancellation is in the sole discretion of Derek O'Neil and/or SQ Worldwide.

- Integrate into your life the five fundamental human values of Love, Peace, Truth, Right Conduct and Non-Violence, and strive to always speak and act in accordance with them.
- Understand that you do not need to always oblige, but must always speak obligingly.
- As a member of the SQ Worldwide family, you understand that you are a Way-Shower, and will set an example for others. You will exercise patience, understanding, kindness and compassion at all times.
- Understand that Love and Truth are the basis of a true spiritual life and are the most important qualities of a person in service to a higher ideal. Strive to always speak and act in accordance with Love and Truth.
- Understand that through unity and cooperation, humanity can heal. Therefore you will be cooperative and supportive towards SQ Worldwide family members and will not engage in competitive behavior with them. Honesty, love, respect, integrity, courtesy and compassion will be preserved in your interactions and communications. Do not gossip or criticize others.
- The terms "More Truth Will Set You Free", "Rising Star Healing Modality", "Rising Star Healing System", "Prema Agni" and the Rising Star and Prema Agni symbols are protected by service mark and trademark laws and may only be used in accordance with written agreements between you and SQ Worldwide or Derek O'Neil.
- If you are a certified SQ Worldwide practitioner or teacher, you will exercise professional etiquette and practice and maintain an appropriate boundary with all students, clients and attendees.
- When applicable, maintain an appropriately private and clean healing room, free from interruptions and distractions.
- Strive to continually move forward on your personal spiritual and healing path, for the clearer and more healed you are within, the more effective you will become. Take responsibility for your own spiritual, emotional, mental and physical health.

- Where applicable, always respect the right to privacy of your clients and students, and preserve the confidentiality of information obtained in the course of a workshop, healing session or initiation.
- Meet people where you find them. Love them enough to understand the world they have created, and allow Source to build a bridge to link us all.
- You are ONLY an expert in your experience. Your experiences are the most valuable tools given to you. NEVER offer advice to a person experiencing an event that you have not personally lived unless you are properly trained and licensed to do so.
- Speak to all in simple, clear language.
- Remember: you are not the doer. Get out of your own way and offer yourself as the vehicle of your own divinity, who you really are.
- Be honest about your limitations. Practice humility.
- If you have completed an official Prema Birthing, Rising Star or More Truth Will Set You Free certification or initiation under the direction of an associated accredited SQ Worldwide Teacher, you will present the respective modality or workshop exactly as it was taught to you.
- Do not offer another kind of healing workshop or system with the name Prema Birthing Healing System, Rising Star Healing System or More Truth Will Set You Free workshop, and do not confuse another kind of healing workshop or system with these trademarked names.
- Do not claim that SQ Worldwide or Derek O'Neill have endorsed any workshop, healing modality or system other than More Truth Will Set You Free workshops, the Rising Star Healing System, Prema Birthing Healing System or other healing work unless specifically endorsed in writing by SQ Worldwide or Derek O'Neill.
- Do not intermix or blend the Prema Birthing Healing System or Rising Star Healing System with one another when conducting a healing session. Do not change the process or procedure of any SQ Worldwide Healing System session or workshop.
- Keep the essence of the Rising Star and Prema Agni symbols and names pure. Do not comingle these symbols or names with other healing modalities or systems on your business cards or flyers. In connection with your practice of the Prema Birthing Healing System or Rising Star Healing System, whenever possible use the business cards or brochures provided to you by, or otherwise approved by, SQ Worldwide.
- If you are a certified SQ Worldwide practitioner or teacher, you will only conduct healing sessions on someone who has requested and given permission to receive healing energies. Do not send healing to someone who is unaware or did not request healing.
- Abide by the Code of Ethics and be able to produce a copy of the Code of Ethics whenever requested to do so.
- If you are a certified practitioner or teacher, or More Truth Will Set You Free facilitator, you will participate in ongoing training in your respective healing system when available.

If you are a certified SQ Worldwide practitioner or teacher:

- Prior to working with a new client, offer them a free healing modality informational brochure and clearly cover the therapy, cost, procedures involved and duration of therapy and healing energies.
- If you are a certified practitioner or teacher, or More Truth Will Set You Free facilitator, it is highly recommended that you obtain professional indemnity insurance and be able to produce a copy of your insurance certificate whenever requested to do so. An excellent insurance package has been negotiated for SQ Worldwide members under a third party insurance company if you choose to purchase it. You agree to indemnify and hold harmless SQ Worldwide, its officers, directors, employees and agents, and Derek O'Neill from any claims brought by your clients or third parties arising out of actions or omissions by you.
- You will not represent yourself as a medical practitioner unless licensed to do so under appropriate laws. You will not guarantee any results or make any promises regarding results of your services. You will not diagnose, or represent that you can diagnose or cure unless you are licensed to do so under appropriate laws.
- Do not countermand the medication or treatment prescribed by a client's medical doctor.
- Ensure that physical symptoms that require medical diagnosis and treatment be referred to a medical doctor before any therapeutic or energetic intervention is administered.
- Have the name of the website of derekoneill.com (or any other website designated in the future by SQ Worldwide), clearly displayed in your therapy room or healing center.
- Offer a client questionnaire form to your clients at the end of your healing sessions.
- If at any time you decide that you no longer resonate with the current policies of SQ Worldwide and wish to surrender your membership, you are free to do so with blessings and best wishes. You will continue to speak and act toward SQ Worldwide, each of its affiliates, its members and family with respect and love, and you know they will offer the same respect and love to you. You will give sincere thanks and gratitude for the love, teachings and lessons provided you through this experience. You will return all SQ Worldwide materials to SQ Worldwide. If you have received any confidential information or communication through your work with SQ Worldwide, you will keep all such information confidential even if you separate from SQ Worldwide. This includes any personal information learned about another individual through SQ Worldwide activities, workshops or healing sessions, any and all business or administrative items to which you may have been privy, and all other items of a confidential nature.
